# NPMHU – LOCAL 303 Chester L. Allbritton Scholarship Program 2024-2025 School Year

The National Postal Mail Handlers Union – Local 303 is pleased to offer the opportunity for dependents of regular craft members to apply for scholarship assistance from the NPMHU – Local 303 Chester L. Allbritton Scholarship Program.

This scholarship program has been providing assistance to deserving recipients since 2015. In February 2015, the Local 303 Executive Board voted unanimously to rename the program in honor of Chester L. Alibritton. Chester held various positions and represented the membership of Local 303 with distinction for over thirty-five years. He served as Local President from 1995 to 2005. Chester was a true believer in the Union Movement, and a tireless advocate for Mail Handlers and all working people. His list of accomplishments and contributions to the NPMHU is lengthy. The National Postal Mail Handlers Union – Local 303 is proud to honor the legacy that Brother Allbritton has left behind.

The purpose of the National Postal Mail Handlers Union – Local 303 Chester L. Allbritton Scholarship Program is to provide financial assistance to dependents of regular craft members (only) who are seeking to further their education beyond high school. This program will award three (3) recipients each, a \$2,000.00 scholarship award.

Applicants must meet <u>ALL</u> the requirements and eligibilities (listed in the application via <a href="www.npmhulocal303.org">www.npmhulocal303.org</a>). Scholarship eligibility details and application instructions are now available. #### **ELIGIBILITY**

- 1. Applicants must be a child/dependent of a member (only) employed by the United States Postal Service. For these purposes, "dependent" includes the member's children under age 26 years, including recognized natural children, legally adopted children, and step children. Members must be current in the payment of their union dues for two (2) years immediately prior to the application period of March 21, 2024.
- 2. Applicants must be a high school graduate, have the equivalent of a high school diploma, or be graduating from high school on or before June 21, 2024.
- 3. Applicants must have maintained a cumulative grad point average of 2.8 or higher, throughout high school and/or college. Sealed high school or college transcripts must be submitted with your application.
- 4. Applicants must follow and complete the four (4) page Application Procedure set forth below.
- 5. To ensure that their college or other post-secondary institution receives the scholarship funds awarded, each successful applicant will be required to provide the Scholarship Committee with written verification that they have been accepted by an accredited institution of higher learning, including a two-or-four-year college, vocational institution, trade or technical school, or other institute of higher learning. (Students pursuing graduate degrees are not eligible to receive the scholarship). This written verification is not needed until after a scholarship is awarded.
- 6. Local Officers and Local Staff of the National Postal Mail Handlers Union Local 303, and their family members are not eligible for these scholarships.
- 7. All decisions to award scholarships will be made by the NPMHU-Local 303 Chester L. Allbritton Scholarship Committee.
